This letter and enclosed CD comprises the Report of Waste Discharge (ROWD) for renewal of NPDES Permit No. CAS618033, Board Order No. R8-2010-0033 (2010 Permit), issued by the California Regional Water Quality Control Board, Santa Ana Region (Regional Board). The 2010 Permit authorizes stormwater discharges from the Municipal Separate Storm Sewer System (MS4) operated by Riverside County Flood Control and Water Conservation District (District), the County of Riverside (County), and the Cities of Beaumont, Calimesa, Canyon Lake, Corona, Eastvale, Hemet, Jurupa Valley, Lake Elsinore, Menifee, Moreno Valley, Norco, Perris, Riverside, and San Jacinto (collectively referred to herein as "Permittees") in the Santa Ana River Region within Riverside County. The enclosed ROWD is due to the Regional Board on August 2, 2014; the 2010 MS4 Permit is due to expire on January 29, 2015.

The 2010 Permit specifies that at a minimum, the ROWD shall include:

- Names and mailing address(es) of the primary administrative and technical contacts for the Permittees that operate the MS4;
- Any revisions to the DAMP including, but not limited to, all the activities the Permittees propose to undertake during the next permit term, goals and objectives of such activities, an evaluation of the need for additional source control and/or structural BMPs, any proposed pilot studies, etc.;
- Changes in land use and/or population including map updates;
- Any significant changes to the MS4 including map updates of the MS4; and


